MINUTES

I. Introductions & Discussion

- How clear is our purpose?

Some of the observations shared by attendees included:

- Issues with conflict resolution and making sense of challenges as a group
- Need to engage members who do not regularly attend meetings
- Tension between emphasis on impacting policy vs individuals
- Need to better communicate the Roundtable's achievements internally and externally
- Need to report out at Planning Council meetings about actions taken by Executive Committee on behalf of the Reentry Roundtable
- Goals are clearly articulated by the "how" lacks clarity for some members
