- I. **12:30-12:45 p.m. Welcome –** Jennifer Tucker welcomed attendees at 12:34 pm. Kelly led attendees in a connecting activity. Jennifer then invited new guests to introduce themselves.
- II. 12:45-12:50 p.m. Voting Items Jennifer Tucker
  - a. **November 2020 Minutes** Dr. Louella Tate moved to approve the November 2020 meeting minutes. Joe Ramirez seconded, and the motion passed unanimously.
  - Woollard Nichols and Associates Contract for 2021 Coalition Support Hank Perret
    moved to approve WNA's 2021 coalition support contract with the Reentry Roundtable.
    Don Tracy seconded, and the motion passed unanimously.
- **III. 12:50-12:55 p.m. Review Workplan Progress –** Jennifer encouraged Planning Council members to get involved in the Roundtable work reviewed. Kelly shared the following updates:
  - a. During the first quarter of 2021, the Executive Committee will work on developing a formal mentorship component for the fellowship as well as improving onboarding and training plans for the next fellow. The selection process for the next fellow is anticipated to begin in March or April of 2021.
  - Kelly updated attendees on the community conversation on reentry co-hosted by the Roundtable and Austin Justice Coalition on December 7. The Roundtable will be submitting the relevant documentation to the City of Austin and Travis County by the end

- of the month.
- c. Kelly provided an overview of the three phases of the service landscape project including survey/data collection, mapping/analysis, and website/web application development. The Planning Council meeting in January will include details and discussion around the first phase as well as a call for workgroup members.
- d. KiYa Moghaddam is working on the 2020 Impact Report and plans to share in the early January.
- e. The Reentry Roundtable and Community Coalition for Health have been invited to submit a full grant application for the Community Solutions for Health Equity from the Robert Wood Johnson Foundation. The application is due by February 2021.
- f. Kelly and Lily Feldman are meeting soon with the Travis County Sheriff's Office to move forward with researching reentry centers and best practices.
