The legislative panel shared bills this session that may have positive or negative impacts on reentry. They also shared that many of these bills will not make it out of committee this Legislative Session, but it is important to stay engaged and continue the fight for progress in these areas. Panelists encouraged Planning Council members to sign up for public comment and to subscribe for committee and bill alerts to stay informed. Ana Gonzalez from Workers Defense Action Fund spoke on SB 14, which prevents counties and city governments from passing policies that set minimum employment policies—such as worker health and safety policies and civil rights protections. WDAF is advocating against this bill.

WDAF is currently advocating in favor of HB 1058 which creates conditional driver's permits for communities that traditionally have not have access to forms of state ID. The campaign website is http://drivetexasadelante.org/. Building Promises USA and Texas Criminal Justice Coalition are advocating for HB 3547 (Allen), also known as New Wings, which would expand record sealing services to many Texans who have completed their sentences but still carry the barriers of a criminal record.
