- a. June 2021 Minutes

# III. 12:50-1:20 p.m. – Reentry Service Mapping Work Group Presentation – Kelly Nichols

- b. Kelly gave an overview of the Reentry Service Mapping Workgroup's survey project purpose and process. Kelly presented a summary of survey responses, survey findings and recommendations. Held a large group discussion around the survey findings. Planning Council members were invited to join the next work group meeting.
- c. Planning Council discussed how this project is one of Reentry Roundtables biggest

accomplishments. Planning Council is excited to share with their networks, and for this work to inform policy changes in the future. Systems map will help prioritize for the next strategic plan.

Matt explained that Aunt Bertha is a social services referral program which powers a site
called FindHelp.org. Anyone can access it for free and connect to services for free. Matt
shared his screen and showed the groups a few of the programs uploaded from the
Reentry Services survey.

#### V. 1:30-1:45 p.m. – City of Austin Reentry Services Grant Proposal Draft

a. Planning Council discussed City of Austin Reentry Services grants for Hub and Spoke awards, and finding Reentry Roundtable's place in this initiative. A strong reentry coalition to support is a really important part of one-stop shop reentry centers. Planning Council discussed having a feedback loop so the entire Roundtable will have a systemic way of Planning Council knowing all these activities. The agreement with grantees should plainly state the expectations for communicating with the Reentry Roundtable. Planning Council members have a lot of expertise to share with grantees.

- The Planning Council Coffee Chat meetup is taking place on Monday August 23rd at 8am.

- Maya Beit-Arie introduced herself as the Coalition and Capacity Building Manager at ECHO. Her role is to build new partnerships and strengthen existing relationships. She announced that ECHO is currently in the process of holding a local competition for federal Continuum of Care funding. - Jen Tucker announced that Goodwill Central Texas has received a large one-year housing stability grant. Funds will become available on September 1st. Jen will keep the Planning Council updated.
- Ramah Leith announced that the Fatherhood Works program at Goodwill Central Texas is currently enrolling fathers and father figures who meet the following eligibility criteria: Reside in Williamson, Hays, Travis, or Bastrop Counties; meet income restrictions; are age 18+; and have a child up to 24 years old. - Carl Hunter announced that he met with Commissioners Alvarez and Demerson at the Texas Workforce Commission to develop workforce development initiatives. Carl hopes to partner with RAP as a recruitment partner, focusing specifically on the tech industry.
