III. 1:10-1:25 p.m. – Presentation on Integral Care's Jail-Based Intake and Care Navigation Program – Karen Boyd

Karen Boyd shared a <u>powerpoint presentation</u> on Integral Care's Jail-Based Intake & Care Navigation Program and answered questions from the Planning Council.

IV. 1:25-1:55 p.m. – Strategic Planning Partnership with MEASURE Update and Introductory Discussion

Kelly shared a proposed strategic planning timeline and overview of WNA's current ongoing partnership conversation with MEASURE.

Activity: Create a 1-2 sentence "problem statement" that explains a problem Reentry Roundtable needs to address in strategic planning. The statement will describe the negative points of the current situation and explain why this matters.

The Planning Council and guests created the following problem statements in groups of 3-4.

- problem when people leave TCCC they often do not have access to meaningful treatment and supports + basic needs
- problem reentry and behavioral health workforce does not have capacity to address the current challenges
- problem funding is siloed and not allocated appropriately
- problem not enough urgency or leadership
- The Roundtable is working to erase barriers to employment, housing and mental health. But, as a convener and facilitator, we talk a lot about how to address the issues but we're not feet on the street to get things done.
- How does the Roundtable ensure that people know who we are and what we do? Do people in reentry know that the Roundtable exists? How can the Roundtable assist folks with lived experience in navigating our network?

- How do we develop, support and advocate for programming that builds upon the current
 ecosystem and addresses the immediate needs of the population that is sustainable over
 time.
- problem siloed and disconnected agencies and service providers reduce opportunities for impact at scale - need to identify models for connection, coordination and collaboration around reentry supports
