III. 12:50-1:05 p.m. – Mid-year Financial Update – Kelly Nichols and Dr. Moody

Kelly provided an overview of the 2023 budget and current income and expenses. Strategies include: negotiating with current funders for additional funds with deliverables next year; gaining new funders and funding strategies; may establish a sustainability committee; and anyone is welcome to donate on the website as well.

IV. 1:05-1:35 p.m. – Presentation from City of Austin Housing Department – Chris Duran

a. City of Austin Action Plan

Christian Duran and Jamie May (City of Austin Housing Department) presented the City of Austin Action Plan and accepted questions and feedback from meeting attendees. The Roundtable Network was also encouraged to share comments using the public input portal: www.publicinput.com/housingneeds or at the public hearing at tomorrow's Community Development Commission at 6:30 PM which can be attended

virtually or in-person.

- The groups discussed reduced lookback periods for any property funded through the program. City's current lookback guidelines in Developer Assistance programs were based in part on the Roundtable's Criminal Background Screening Guide. Maximum lookback periods are 3-5 years for family properties and 1-3 years for single occupancy properties; there is also an appeal process. These lookback period guidelines were developed with property managers and these guidelines were implemented in 2021.
