Barbara shared that she has hit the ground running with her advocacy fellowship and has participated in community events and professional development. She attended Leadership Austin's Civic Activation Conference last week and is currently finishing her application for the Leadership Austin Emerge Program. She is also participating in the Hogg Fellowship program as a guest fellow. This is a longstanding partnership the Hogg Foundation has had with the Reentry Roundtable. Barbara facilitated her first RAP meeting last Wednesday, where the group talked about Pride and Juneteenth community events and offered peer support. Barbara will participate in Toastmasters next week.

IV. 1:05-1:50 p.m. – Member Program Updates & Rapid Coordination

a. Sandra Eames and Nadine Scamp -- Austin Community College and Santa Maria Hostel Nadine joined us from Santa Maria Hostel Recovery services in Houston, Texas. Santa Maria is one of the only places in the state where women can bring their children with them while they receive treatment. They work closely with TDCJ and local medical providers to make sure services meet the needs of participants.

They have seen an increase of participants coming from Austin in the last few years since Austin Recovery closed their family program. Santa Maria is now exploring the option of opening a location in Austin to keep folks connected to their community. They are looking to identify space and start up funding to make that happen. There will be monthly meetings to plan, and anyone from the Roundtable network is invited to participate. They would like to have the residential program established by late 2024. b. Carl Hunter, Theo Adams-Hernandez, and Jeremy Jones -- Building Promise USA Building Promise was chosen in 2021 by the City of Austin to be the coordinating agency for reentry services in Austin, and the BPUSA team has been growing and expanding infrastructure to be that single point of access for folks who are exiting jail and prison. They have hired a program manager, Theo Adams-Hernandez, and have become a certified Peer Support Specialist apprenticeship site. So far, they have provided support to 94 clients.

Right now, they are working on workforce development programs (RESPI and HIRE) as well as significant updates to their website and technology. They also plan to launch a diversion program in 2024. They have launched TEXConnect on their website, which is powered by findhelp, to manage referrals and connect clients to resources. Anyone may complete the intake form on their website and a peer support specialist will respond. Their office is also open for drop-ins and to use the computer lab. Building Promise is located at 6633 East Hwy 290, Suite 104, in a location with nearly 20 other Black-led nonprofit organizations. - c. Open Space: After the two group presentations, the floor opened for anyone on the meeting to share a question, challenge, update, or new initiative.
- Robert Lilly spoke about the need for family resources, particularly guiding resources for supporting family members with complex mental health needs. He spoke about his experience

with his family member is currently incarcerated in TDCJ. Misty Campbell and Maggie Luna suggested that Robert speak with April Zamora and Chris Carter, and they will connect with him after the meeting to support that process. - Jesse Rojano shared that he is a recruiter with Walsh construction, which is a second chance employer who does not discriminate based on system-involvement. - Misty Campbell, Reentry Specialist at Austin Community College, announced that she will now start reentry before release through Building Promise's referral system.
- Paola Silvestre shared that Indeed has partnered with Skillpoint Alliance to provide financial support to the folks that go through their manufacturing training program. Indeed is providing a \$400 per week stipend while completing the training. - Robert Kingham announced that City Council has approved an exploration of DACC jurisdiction expansion, and they will be engaging stakeholders soon for community feedback. DACC's current jurisdictional boundaries are the downtown core area; MLK to river; 35 on east to Lamar on West and also include West Campus and a little bit of East Austin.
- Cathy McClaugherty reminded the group about the Travis County resolution to create a mental
 health diversion center in our community. There will be a town hall on July 25 to hear from
